The Library has recently purchased an institutional license to BioMedCentral (BMC), an independent publisher of online journals and databases. The subscription includes access to:

- > 57 full-text electronic peer-reviewed medical journals
- > 30 full-text electronic peer-reviewed biological journals
- Clinical trials database
- Meeting abstracts database/journal supplements

These resources are available from the University's gateway page, http://www.biomedcentral.com/inst/gateway. In addition, the journal titles are also available from the Library's E-Journals webpage, and the two databases are linked from the Library's Databases/MEDLINE webpage.

The publisher strives to make research information available as quickly as possible. Therefore, once an article has gone through the peer-review process and been accepted for publication, both full-text html and pdf versions of the paper are published online within a few days, and the article is indexed in PubMed within a week. All BMC journal titles are also permanently archived in PubMedCentral.

Web of Science

What is Web of Science?

The Web of Science database consists of three multidisciplinary indexes of bibliographic information. The three indexes are Science Citation Index Expanded, Social Sciences Citation Index, and the Arts & Humanities Citation Index. Science Citation Index Expanded indexes 5,700+ journals across 164 scientific disciplines. Some of the disciplines covered include Biology, Chemistry, Medicine, Pharmacology, Physics, and Veterinary Science. The Social Sciences Citation Index indexes 1,725+ journals across 50 disciplines. Some of the disciplines covered include Anthropology, Psychology, Psychiatry, Public Health, and Social Work. The Arts & Humanities Citation Index indexes 1,144 of arts and humanities journals, along with relevant items from 6,800+ science and social science journals. Some of the disciplines covered include Architecture, Dance, History, Linguistics, Music, Philosophy, and Religion.

You can search just one of the available indexes or all three indexes at once. Searching all three indexes together is the recommended way to find the largest range of articles on your topic.

The available search options are topic, author, journal, and/or author address. A unique and highly prized feature of Web of Science is the Cited Reference Search option. This option allows you to search for articles that cite an author or article that you specify.

You can access the Web of Science database via the Databases/MEDLINE page of the Library homepage. It is available both on- and off-campus.

There are some advantages to publishing in a BMC journal. The author retains copyright of the article, and he/she can also track the number of times the article has been viewed or downloaded. The Library's institutional license also allows accepted authors to waive the \$500 publication processing fee charged by BioMedCentral for publication of an article.

Understanding Electronic Holdings & Availability

As electronic resources of all kinds–books, journals, Internet resources—become increasingly "available", it is sometimes challenging to remain aware of the extent of actual availability of the different journal resources. Adding to the challenge is the fact that the world of electronic availability is in a state of flux right now as more and more resources become digitized.

As publishers see the increasing availability and popularity of electronic resources, many different types of efforts are underway to ensure that each gets a piece of the pie. Some publishers are offering different types of "subscriptions" to their electronic resources to supplement the more traditional hard copy resources. While some are a part of the traditional hard copy subscription and need only to be "turned on" to make them available electronically, many other arrangements currently exist and continue to change frequently. That is exactly the reason why a specific resource may be "here" today and "gone" tomorrow. Libraries often cannot control these changes. The end result will probably mean increasing costs for electronic resources, something libraries are already seeing.

To help in the challenge of understanding availability better, the Library has prepared the following short list of the types of statements one might see on the Homepage indicating how much of a journal resource is available online and through what service. Availabilities are varied because publishers are at different stages in digitizing past journal years and also because different costing structures by the publisher make different years available.

- Dates Indicated (19xx-Present): The journal is available from January of the first year noted through the most current issue made available electronically.
- Current X Months Only: The journal is available only for the most recent number of months indicated. When a new month's issue is added, the oldest month's issue is removed.
- » Archival: The journal is available from first date noted to last date noted.

Currently, Himmelfarb uses the following services to provide access to journals online:

- > Ovid
- Proquest
- Ingenta/Catchword
- MD Consult
- Lexis/Nexis
- Publisher

For the most part, the actual service used may impact the user only if he/she does not have access to that service (such as MD Consult) or if a resource is only available on-campus. It is also possible to link directly to some journal resources when doing a search on an Ovid database. See the Himmelfarb Homepage for more details at /.

Search results are organized into 4 categories: Evidence-Based, Query-Answering Services, Peer-Reviewed Journals, and Practice Guidelines. The site is updated monthly.

Contextual information is information relevant to psychological and cognitive development, psychoneuroimmunology, family, cross-cultural medicine, medical ethics, and health economics and policy. If you search MEDLINE regularly, you are probably comfortable using MeSH terms, subheadings, and limit tools to find biomedical and clinical information. Contextual information may be a less familiar domain to research. However, some simple search strategies combined with appropriate terminology can help you start your research.

When you search MEDLINE or PsycINFO, keep a basic framework in mind including:

- > Use focus (Major MeSH) on disease concepts and/or contextual concepts
- Do not use focus (Major MeSH) on population groups (Whites, Blacks, etc.) in initial searches.
- For best results, search on several 'contextual concepts' at once. For example, you may create one search set combining Social Class, Cultural Characteristics, and Socioeconomic Factors.

BASIC SEARCH STRATEGIES

- Combine disease search with contextual concept search

- 1. *Stomach Ulcer/
- 2. *Socioeconomic Factors/
- 1 and 2

Example: Levenstein S. Kaplan GA. Socioeconomic status and ulcer. A prospective study of contributory risk factors. Journal of Clinical Gastroenterology. 26(1):14-7, 1998 Jan.

Note: this subheading strategy works in MEDLINE, but not in PsycINFO. 1. *Helicobacter Infections / Ethnology

SUBHEADINGS

When searching MEDLINE (but not PsycINFO), the subheadings for economics, epidemiology, ethnology, and psychology can be used with disease/condition terminology or contextual terms to focus searches on a particular type of information.

- Add subheading to disease/condition terminology Helicobacter Infections / Ethnology

- Add subheading to population group Whites / Psychology

- Add subheading to contextual term Family / Ethnology

CONTEXTUAL CONCEPTS

The contextual concept subject headings in this section are not exhaustive, but represent starting points to explore different topic areas. Many terms work when searching MEDLINE or PsycINFO. Sometimes however, PsycINFO uses different terminology which is also supplied.

POPULATION GROUPS

You can search by population group to locate information about a particular ethnic or racial group. The subject terms for some population groups may not be the current preferred group name. For example, to find information on African-Americans, the correct subject headings is 'Blacks.'

Also, while the subject headings for some population groups incorporate a geographic region (ex: Hispanic-Americans), others require additional search strategies outlined below to ensure that you find information about U.S. populations (i.e. Arab population in the U.S. rather than in France). The subject headings for some U.S. population groups are Blacks, Whites, Arabs, Hispanic-Americans (PsycINFO: Hispanics) and Asian-Americans (PsycINFO: Asians).

- Search by population group and United States to focus on information on these population groups in the United States.

- 2. exp United States/
- 1 and 2

- Combine population group searches with keyword searches.

Note: Keyword searches are denoted by '.mp' after the word or phrase.

Using the truncation symbol (\$) retrieves instances of this word/phrase with any ending and thereby retrieves both singular and plural occurrences.
